All Greyhounds coming into the GAP NSW program must have an up-to-date C5 vaccination and at least the initial part of the C7 vaccine (i.e. the first C2i injection). If assessment and entry to GAP occurs within 2-4 weeks of this initial injection GAP will complete the C7 vaccination course. If this period is greater than 4 weeks you must complete the C7 vaccination course by getting a second C2i injection prior to coming into GAP.

Up-to-date vaccination means:

You have a record of your greyhound's C5 puppy vaccinations and boosters thereafter (yearly or as per the vaccine manufacturer's instructions), including at least the first C2i injection completed at least 2 weeks prior to assessment.
The last C5 vaccination must also have been done at least 1 month prior to pre-assessment.

Proof of vaccination is required and means:

A vaccination certificate/card for your greyhound detailing the vaccine/s and signed by your veterinarian or a veterinary invoice for the vaccination/s with your greyhound's details listed
